SECRETARY'S ANNUAL REPORT-2020-21

Dear esteemed members of IMA'S-KSSS a warm regards and greetings from IMA's Karnataka Social Security Scheme, Hubballi to one and all.

I am honored and privileged to present the Secretary's Report for the year 2020-21. The team of enthusiastic Managing Committee members is very much encouraging to the growth and financial stability of our scheme.

The enrollment of new membership to old existing Scheme and New Silver Jubilee Scheme is as follows:

The DFC-10 and DFC-5-SJ was collected from 1st April-2021 onwards for maximum of 15Deaths occurred after the previous DFC - 9 collections of Old Existing Scheme and three deaths in New Silver Jubilee Scheme after the previous DFC-4 SJ collection. (Details enclosed).

This year we have introduced Online Payment Gateway System for DFC payments with Auto generation of DFC receipts and SMS/Email alerts.

After the recent Amendments to Rules and Bye-laws of IMA's-KSSS we are disbursing 100% of DFC contribution to the nominees of bereaved family. The IMA-KSSS has decided to give 1.5 times the death claim amount to bereaved families if death occurred due to Covid-19. It was also decided to remove lock in period if death occurs due to Covid-19. Till today we have extended Covid benefit to 12 members in old existing scheme and to 3 members in new silver jubilee scheme.

The IMA-KSSS has disbursed death claim to nominees of 22 demise members in Old existing scheme and 5 demise members in New silver jubilee scheme since the previous Annual General Body meeting. The total amount disbursed to the bereaved family is Rs44866162/- (Four crore forty eight lakhs sixty six thousand one hundred and sixty two rupees only) in Old existing scheme and

Rs.**2,14,15,000/-**(Two crore fourteen lakhs fifteen thousand rupees only)in New Silver Jubilee scheme.The amount includes Covid death benefits also (list attached)

The recent death claim benefit to single member in Old existing scheme is Rs.**17,31,701/-**(Seventeen lakhs thirty one thousand seven hundred and one rupees only) and in New Silver jubilee scheme is Rs.**45,65,000/-** (Forty-five lakhs sixty-five thousand rupees only).

In death due to Covid-19 IMA-KSSS disbursed Rs.**2,59,66,301/-**(Two crore fifty-nine lakhs sixty-six thousand three hundred and one rupeesonly) in Old Existing scheme and Rs.**1,27,27,500**(One crore twenty-seven lakhs twenty-seven thousand and five hundred rupees only) in New silver jubilee scheme.

This year total of 143 members are completing 25 years of their membership in Old Existing Scheme. Till today total of 566 members have completed 25 years of membership in Old Existing Scheme.

We have paid accidental death benefit premium renewal of Rs.**8,50,000/-**(only) with Royal Sundaram General insurance company, Bengaluru.

The Audited accounts along with the Balance Sheet and the Budget proposal are submitted here with. We have uploaded the minutes of previous AGM and all the MC meetings on our website (<https://imakssshubli.org>). The details of progress of court cases and investigations in the fraudulent withdrawals of money from IMA-KSSS accounts has been separately attached.

After discussion it was decided to with draw additional death benefits extended and relaxation in Lock-in period for Covid deaths to members who join any schemes under KSSS on or after 31/10/2021, i.e.after Annual General Body meeting to be held on 30/10/2021 at J Max Theatre, JVS Limited,JSW Township,Vidyanagar,Toranagallu,Ballari District.

It was also decided to extend additional Covid benefits and relaxation in Lock-in period till 05/06/2022 if death occurs due to COVID to all those members who joined on or before 30/10/2021.

Agenda 16:- Discussion on Capping of DFC payments Amount-Invitee Mr Saji,Financial Advisor KSSS

Secretary Dr. Prakash Reddy K.T and Dr. Sharanappa J started discussion about Capping of DFC Payments and Death Claim Benefits due to sudden rise in number of deaths. Mr. Saji Financial advisor for IMA KSSS expressed concerns about financial viability and longevity of the schemes if capping is introduced and also tried to convince about temporary phenomena in rise in death rate due to unprecedented COVID 19 Pandemic. He also explained about balancing or levelling effect which would happen in near future and possibility of present crises getting solved at the earliest. He also suggested to utilize interest earned over the years as co-payments to death claims or spread over DFC Collections to lessen the burden.

However, members felt about need for detailed deliberation regarding capping of DFC and Death claim amount.

After listening to all the discussion Chairman gave ruling to form the following committee to deliberate the matter along with financial advisor Mr. Saji.
