- 1. Majority of the members agreed to legal advisors opinion of fighting the case in court of law. All the members re-iterated the decision of dishonoring the claim to nominees of Dr.S.A.Subbaraju (AG2232 & SJ1324) of 8<sup>th</sup>, 9<sup>th</sup> & 10<sup>th</sup> MC Meetings.
