2) As proposed by Dr.Sharanappa Janthakal:

Proposing the following amendments, to the Byelaws of IMA-KSSS in respect to ELECTIONS TO "IMA - KSSS MANAGING COMMITTEE".

Eligibility to contesting candidate:

- a) **M C Members.** should be an ACTIVE MEMBER OF IMA-KSSS (That means he/she should complete 2 years after admission to IMA-KSSS).
- b) Joint secretaries. -He/She should have worked as M C Member at least for ONE TERM
- c) **Other posts** chairman, / secretary/ Treasurer/ vice chairman. He/she should have worked as MC Members at least for TWO TERMS.
- d) As for as possible secretary and Treasurer should be from. HEAD QUARTERS OR nearby with in 50 KM.

e) Disqualification of MC members

WhoeverMC member absent for MC meetings continuously three times without earlier permissions from the chairman with valid reasons should be disqualified for contesting in the elections to IMA-KSSS for three years.

Decision:After detailed discussion proposals of Dr.Sharanappa J regarding elections were not accepted and decided to maintain Status –quo.

3) As proposed by Dr. A.S. Mantganiker and Dr. Sharanappa Janthakal:

Proposing amendments to IMA -KSSS Bye laws regarding payment in advance (while in life) about 3 to 5 lakhs rupees to who are Permanently disabled and suffering from End stage diseases and active members of IMA-KSSS

Decision: After detailed discussion above proposal was not accepted due to lack of financial feasibility.

4) As proposed by Dr.Abhay Matkar on behalf of IMA-Hubballi members:

Members of IMA Hubballi Branch unanimously request you to please consider IMA KSSS schemes for those over 60 years of age.

Decision: After detailed discussionthe above proposal was not accepted due to lack of financial feasibility.

- 5) Dr.Sharanappa J proposed to introduce capping of membership and capping of Ex-gratia payments to bereaved family.
 - After detail discussion it was decided to make a committee of following members to come with detailed proposal. The committee members will be 1) Dr.Sharanappa J 2) Dr.S.K.Nara 3) Dr.Sachin Revankar. It was also recommended to committee to bring detailed proposal by next meeting.
- 6) Chairman suggested for need to amend the Bye-law "Section -5 Disbursement" as few members are completing 25 years of membership and ex-gratia payment if calculated as per the present Bye-law, there would be financial non-feasibility to IMA-KSSS.

House discussed in detail and decided to take opinion of financial expert Mr.K.S.Saji by next meeting and put-up possible amendments.

LEGAL OPENION

Sub: Legal opinion with reference to your letter dated 11/05/2019 with respect of deletion of the word

terminated and to add the word suspended in Sec.6 (b)(iii).

With reference to the above subject I would like to give my opinion as fallows.

1. If a word is inserted or added as "Suspended" by deleting the word "Terminated" which will definitely

create the legal obligation to pay the compensation with respect of death claim as contained in your

scheme and that obligation will not end until the member is terminated. The literal meaning of the word

suspended means a member is suspended and his membership is kept in abeyance for non-payment of

subscription, hence keeping the member in suspended position will not absolve your organization from

the liability to pay death claim. Whereas the termination of the member will cease such member from

having the benefit of the scheme for his default and he can revive his membership as stipulated in your

scheme. I suggest not alter any words in the Sec.6(b)(iii)

2. My legal opinion is based on the photo copies of your By-Law documents and based on that only I have

given my opinion. Hence this legal opinion.
