After going through the claims of death received from the nominees of the above deceased members, the House unanimously decided to award the above death claim settlement amount as per the formula derived in the MC meeting held on 1.11.2015:

The House was informed that the above death claims are calculated taking into account the active members as on last day of the respective month during which the death occurred including the revived defaulted members on that date. The membership revival of defaulted members is upto 31.12.2016 as per the decision of 22nd MC meeting held on 17.7.2016. Therefore, the House decided to pay the final amount towards death claim to the nominees of above 3 deceased members as second cheque, taking into account the total revival of membership as on 31.12.2016 and to inform the concerned accordingly.

The Secretary further informed the House that excess payment has been made to the nominees of late Dr V S Huilgol of Gadag Branch (AG-0439) and Dr S S Narasanagi of Vijayapura Branch (AG- 0397) based on the calculations made previously. However, this will be set right at the time of making final death claim payment to them taking into account the receipt of DFC-5 by 31/12/2016 . The House approved this unanimously.

It was decided to prematurely close few FD's of Old Existing Scheme (which are recently deposited) to pay the death claim amount.

All the members were requested to motivate the defaulters in their respective areas to revive them.

Then Dr.Yuvaraj Patwardhan expressed as follows

Some senior members spread wrong messages about IMA-KSSS by highlighting the fraud that happened recently & discouraging the new members who are about to enter the scheme. He requested all the senior members to clear the doubts.

Dr.Nara also reiterated the same.

Dr. Mantganiker said if such members are non-members they do not have right to comment , Dr. Kanchi added that let us act positively & convince all the members and motivate patiently.

Chairman Dr.Y C Yogananda Reddy answered as “let all of us accept the comments in a positive way. In democratic setup everybody has rights to express their views irrespective of their membership status. Let us give them proper reply & convince them”.

Agenda 10: Receipt & Payment: The Secretary presented the Receipt & Payment statement for the period from 24.10.2016 to 26.11.2016 wherein it was shown that the total amount received is Rs.6,35,600 against the payment of Rs.27,98,093 during the period. The Secretary also informed the House that the details of receipt and payment for the period have been presented in a new format giving full details under various heads of accounts. This format would be applied in future presentations also. The statement showing the funds position as on 26.11.2016 of the Institution was also presented to the House, wherein the total amount available in SB accounts at Karnataka Bank, NCM and Durgadabail Branches and Canara Bank, B N Nagar Branch is Rs. 32,70,798.63 including cash in hand and the total amount available in FDs (88 Nos) is Rs.5,50,51,208-00, both together comes to Rs.5,83,22,006.63. The Secretary clarified that an amount of Rs.11,235/- is incurred towards transport of

books, documents, records pertaining to AGM including election materials and office staff to Tumkuru. The House reviewed the funds position along with receipt and payment details and unanimously approved the same.

Dr S K Nara suggested to keep remaining Rs.26,000/- received towards nomination fees from contestants during IMA-KSSS election 2016 as FD. The House approved this unanimously.

Agenda-11: Office related matters, if any:

The matter of payment of annual bonus to office staff for the year 2016-17 was discussed and it was decided to pay one month's salary to the office staff towards bonus.

Agenda-12: Correspondences, if any:

Dr S K Nara's e-mail dated 25.11.2016 was read and the compliance wherever necessary was furnished in the House. The House approved the same unanimously.:

Agenda-13: Any other subject with permission of the Chair:

- (1) Authorisation to file complaint and appear before State Consumer Commission, Bangalore by the Chairman: This subject was discussed in this MC meeting and the House unanimously decided to authorise the Chairman of IMA-KSSS Dr Y C Yogananda Reddy to file complaint and appear on behalf of IMA-KSSS before the State Consumer Commission, Bangalore regarding cases to be filed against the Karnataka Bank and to continue to represent the appeal filed against Canara Bank regarding fraudulently withdrawn money from IMA-KSSS bank accounts.
- (2) Membership of non-IMA members: The House discussed this issue and it was unanimously decided to get the IMA Life Membership of those of IMA-KSSS members who do not possess the same by paying necessary fees from IMA-KSSS to IMA (HQ) during July/August when membership fees would be expectedly slashed. It was also decided to deduct this sum out of the death claim of the respective members later.
- (3) **Finalisation of members completing 25 years:** It was decided to consider 31/03/1992 as the commencement of the KSSS scheme according to year of registration. The secretary said that as per this 236 members of the Old Existing Scheme would be completing 25 years in 2017. For them the DFC-6 to be collected during April 2017 would be the last contribution, and house unanimously accepted. It was unanimously decided to request all the members completing 25 years to motive and enrol at least one new member to the Old Existing Scheme so as to maintain its sustainability and viability. Accordingly it was decided to send letters to above said group of members.
- (4) Revival of defaulted/terminated member: It was unanimously decided to grant revival of membership under Old Existing Scheme of IMA-KSSS to Dr V Srinivasa, AG-285 From Tumkur & Dr. P.V.Maragi AG-915 from Gadag on similar lines as per 23rd MC meeting held on 11-9-2016.
- (5) Legal expenses: It was unanimously decided to approve the payment of Rs.35,000/- made so far to Sri U S Yogesh Kumar, Advocate, Bangalore against his bill of Rs.65,000/- towards issuing legal notice and filing of case in State Consumer Commission, Bangalore against Canara Bank.
- (6) New office premises: The present office premises of IMA-KSSS is found to be inadequate and congested. It was, therefore, decided to take the adjacent premises (hitherto occupied by Canara Bank) for use of IMA-KSSS office on monthly rental of Rs.12,000-00. The said premises require some interior renovation for which authorised the Chairman/Secretary to look into the matter and arrange for needful. To incur the necessary expenditure in this behalf was also approved by the House.

- (7) Dr. Nara raised about appointment of internal auditor. Chairman said in old bye-laws of IMA-KSSS internal auditor appointment was there but in subsequent amended bye-law the appointment of internal auditor is not existing. Hence this matter was adjourned till the auditor's opinion is taken.
- (8) Dr.Sharanappa suggested to study Tamilnadu model which is having 10000 members and is without DFC contribution & only one single payment. Chairman assured to study it and then answer in subsequent meeting.
- (9) Dr.Kittur suggested to appoint promotional manager or marketing mangers on commission basis. Chairman answered to discuss in next meeting under a separate agenda.
- (10) Secretary asked permission to print bye-laws and purchase stationeries and house unanimously permitted.
- (11) Dr.Mahesh Kumar spoke to adopt old tariff of existing scheme till 40 to 45 years age , but house rejected.
