Chairman requested the MC members to motivate all the defaulters of their area to regularise them before 31st December 2017.

Agenda-10: Progress report on fraudulent withdrawals from IMA-KSSS accounts

a) Writ petition in High Court of Karnataka.

- 1. The Chairman presented the charge sheet filed and briefed about the contents.
- The Chairman also told about the need to file application under section 319 in the code of criminal procedures to include and proceed against bank officials appearing to be guilty of offence. Chairman took the permission from the house to proceed further regarding the same and talk to Advocate Mr. Hanumaraddi.
- 3. The Chairman said the house that the second accused was not yet traced and office would help the Police towards the same.
- 4. The Chairman also said about the need to assist Public Prosecutor through Advocate Mr.Hanumaraddi for which house agreed to go ahead.

b) Progress in State Consumer commission, Bangalore.

1 The Chairman told that both the cases in State Consumer Commission are at evidence level

Agenda 11: Receipt & Payment:

Treasurer Dr.Mahesh Kumar presented receipts and payments details and funds status from 03.09.2017 to 25.11.2017 and house after discussion unanimously approved the same.

The house decided to park Rs.1000000/- (Rupees Ten Lakhs) from Silver Jubilee SB account of Karnataka Bank, NCM branch to investment in mutual funds under SJ scheme.

Agenda-12: Office related matters, if any:

- 1. The Deepavali bonus amount equivalent to one month salary to all the office staff of IMA-KSSS was ratified.
- 2. It was decided to purchase UPS system to the office after getting the quotations. The house directed the office office bearers to consider the lowest quotation and proceed further. The house also insisted to include annual maintenance of UPS system.
- 3. The office staff raised the issue of few membership applications having received without signature of local branch Secretary. After discussion house decided to accept them with any MC member's signing in place of local branch Secretary in such cases and same to be followed in future also.

Agenda-13: Correspondences, if any:

The request for refund under VRS by Dr.Gnaneshwara K B (AG.1240) of Hubballi branch discussed and decided to write the official letter to the member to reconsider his decision.

Agenda-14: Any other subject with permission of the Chair:

1. Regarding implementation of amendments confirmed in second Special General Body Meeting held on 26th Nov 2017 at IMA-House Hubballi.

The house discussed in detail and unanimously resolved as follows

- a. The amendments should be sent to Registrar of Societies immediately.
- b. From the date of approval by the Registrar of Societies the new amendments shall come into force.
- c. The deaths happening after the date of approval by the Registrar of Societies shall be eligible for death claims as per the new amendments.

- d. The deaths happened earlier to the date of approval by the Registrar and reported late shall not be eligible for death claims as per new amendments.
- e. The Tally accounts of IMA-KSSS to be password protected and should be known to office clark who holds the responsibility of accounts and to Treasurer, Secretary and Chairman of IMA-KSSS.
- 2. It was decided to collect Rs.7000/- short amount in membership fee from Dr.Kantha Raju from Hassan branch (SJ0601)
- 3. The Chairman raised the point about number of nominees permitted from the new members. The house decided to accept more nominees apart from what is mentioned in application form, but details should be furnished in additional paper as attachment. It was also decided to accept all the additional nominees hither to found in earlier application forms.
- 4. The payment of Rs.4000/- to advocate Ajit H Kademni towards collecting charge sheet was ratified.
- 5. The Dr.Yuvaraj Patuvardhan suggested to announce death claim details of beneficiaries in the social media, however house did not approve the same. At this juncture Chairman said that the same are regularly printed in IMA-Focus and most of the benefit cheques are distributed to nominees through local branches in specially arranged meetings, which is sufficient for publicity.

With vote of thanks presented by Dr. S.B.Lakkol, Joint Secretary, the meeting concluded its business of the day.
